The chairperson conveyed the thanks to the members for attending the meeting and the members agreed that the committee will meet every quarter on a regular basis or earlier, if need arise.

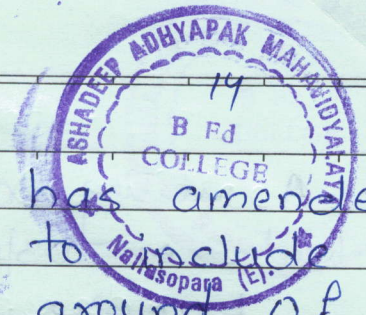



3(j) Any act of Physical or mental abuse target at another student [Fresher or otherwise] on the ground of colour, race, religion, caste, ethnicity, gender, sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

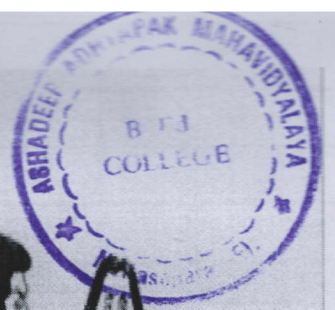

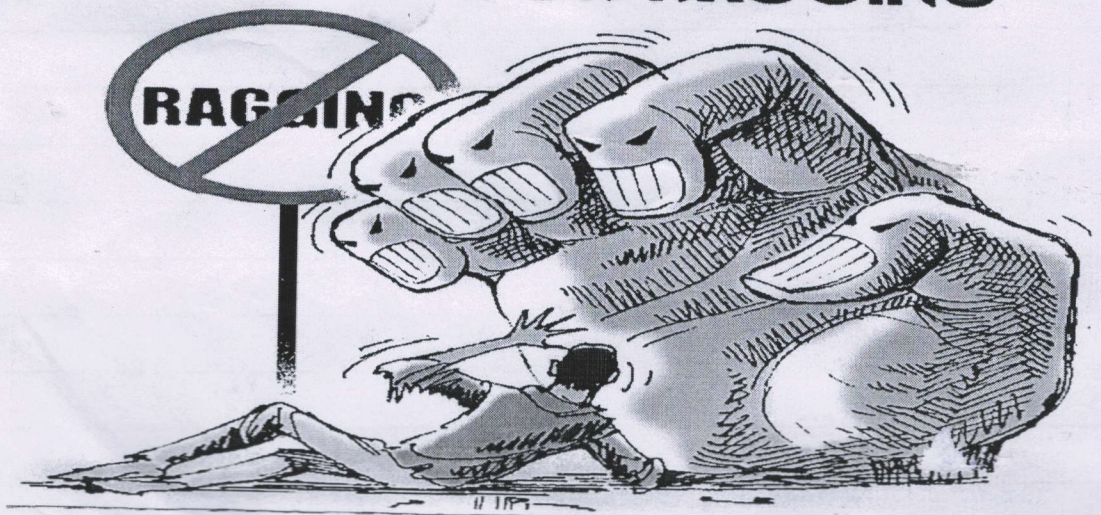

# ANTI - RAGGING.



Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or a junior student. Indulging in a rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student.

Asking the students to do any act or perform something which such student will not do in the ordinary course & which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of fresher or a junior student.

## NATIONAL RAGGING PREVENTION PROGRAM.

In May 2019 the Hon. Supreme Court of India ordered implementation of what is now known as the National Ragging Prevention Program. This program was designed by the Aman Movement & is now being implemented by Aman from January 2012. Besides its success in eradication of ragging it is an example of successful partnership between government & non governmental agencies & use of Technology in management & monitoring of social sector programs.

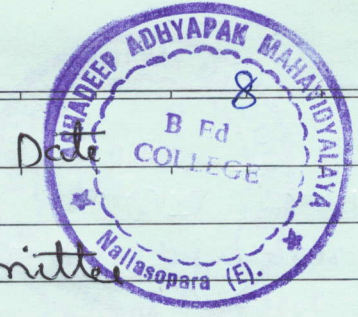

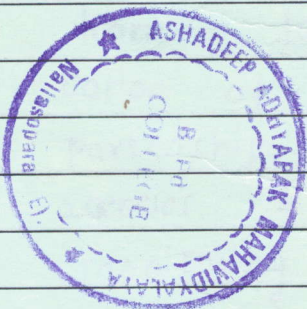

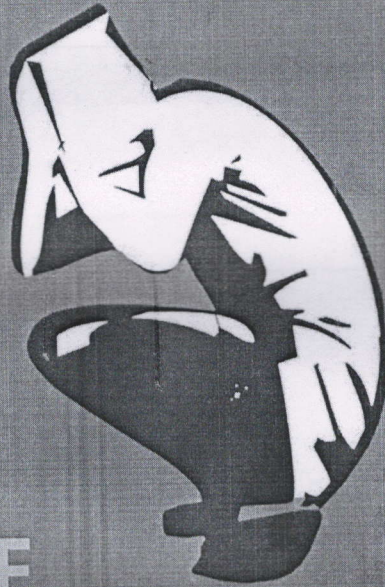

GOT NO HELP FROM ANYONE

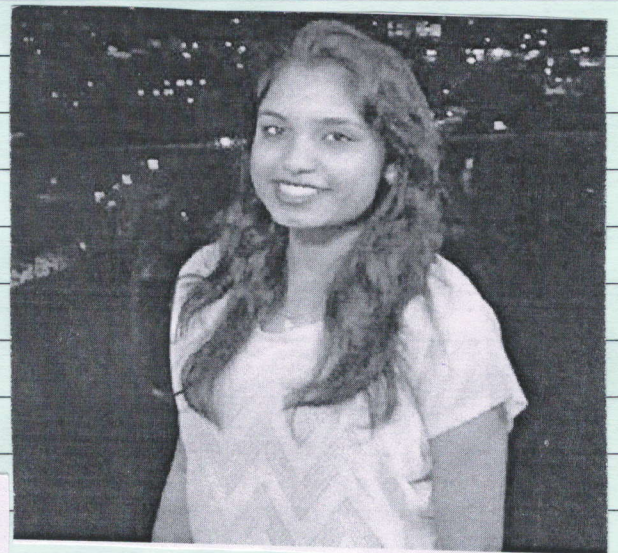
- RAGGING CASE (May 23<sup>rd</sup>, 2019)

The recent suicide by a post-graduate student of Nair-Hospital's Gynaecology Department was a clear case of ragging, a report submitted by the hospital's anti-ragging committee has said.

The report to the maharashtra university of the Health sciences (MUHS) on Tuesday by the hospital's dean, said it could not establish if caste slurs were used in the ragging of Dr. Payal Tadvi by three of her seniors - Dr. Hema Ahuja, Dr. Bhakti Mahere and Dr. Ankita Khandelwal.

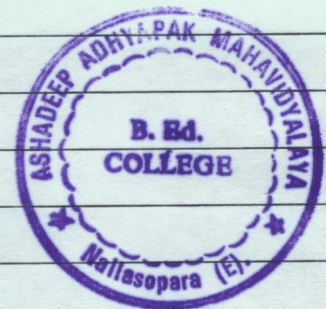



Objectives:-

In view of the directions of the Hon'ble Supreme Court in SLP No. 24295 of 2006 and Civil Appeal Number 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the All India Council for Technical Education, (AICTE) brings forth these Regulations.





## I. Anti Ragging Committee

- a) To ensure compliance with the provisions of UAC regulations 2009 at the institute level.
- b) To monitor and oversee the performance of Anti-Ragging squads in prevention of ragging in the institution.
- c) To take appropriate action in case an incident of ragging is reported by Anti-Ragging squad of the institute and to further inform/get approval of action to be taken from University Anti-Ragging committee.

## II. Anti-Ragging squad

- a) To make surprise raids on academic blocks/hostels and other places vulnerable to incidents of and having the potential of ragging.
- b) To conduct on the spot enquiry/action in to any incident of ragging if noticed.
- c) Anti-Ragging squad shall maintain the record in the register of the surprise visits.
